I. Description of Requested Services. The Town of Pollocksville, North Carolina (the "Town") is seeking proposals from any interested party ("Applicant") for maintenance services ("Services") relating to the planted areas within the Main Street right-of-way. Services being requested include the following, at minimum:

- Weeding / Pruning
- Application of Post-Emergent Weed Control

Services being requested are to occur at least twice per year throughout the growing season. The extent of area included in the scope of work is between the sidewalk and back-of-curb on both sides of Main Street between East Street (at Riverfront Park) and Foy Street. This area is equal to approximately 1,940 linear feet (890 linear feet on the west side of Main Street; 1,050 linear feet on the east side of Main Street), and includes a mixture of the following plants: *Itea virginica* ("Virginia Sweetspire"), *Schizachyrium scoparium* ("Little Bluestem"), and *Liriope muscari 'Big Blue'* ("Lilyturf").

The Town is anticipating the number of labor hours associated with the requested services will not exceed one-hundred and twenty (120) labor hours per calendar year. This is to be a twelve (12) month contract with the opportunity to renew annually.

II. Submission Requirements. Interested parties are to include the following information in a written submission package:

- Minimum Requirements:
 - Qualifications Statement (i.e., brief statement describing the Applicant's capability to complete the requested scope of work).
 - References (provided for at least two (2) past projects of similar scope).
 - Proof of Insurance

- Proposal:
 - Annual Cost Proposal (itemized by Hourly Rate and Additional Materials Cost)
 - Proposed Maintenance Schedule
- **III. Selection Criteria.** The Town will enter into contract negotiations with the Applicant that demonstrates the most cost-effective and responsible proposal.
- **IV. Submission Instructions.** The deadline for submitting a response to this RFP is February 5th, 2025 at 1:00pm EST.
